### **Public Comment**

The following person(s) addressed the Commissioner: Kim Brown commented in regards to the fee schedule for the fishing vessels. Mr. helms commented this issue is on the agenda to be discussed and if there are any questions all of them will be answered at that time.

Commissioner Feller asked in regards to the diesel flat bed truck. Mr. Helms commented the truck got the injectors replaced and is working. Once it decides to die we than will get rid of it. Commissioner Feller asked how long is the Zap supposed to be under warranty. Mr. Helms commented the Zap is not under warranty. President White asked Mr. Helms to give an update in regards to the repairs. Mr. Helms commented that Commissioner Bailey made a donation to the Harbor to cover the cost for the repairs. President White asked in regards to the nautical software. Mr. Helms commented it was the Marina Program. President White asked in regards to Stover Englund Marine. Mr. Helms commented it was for charges to relocate water lines.

ON A MOTION BY COMMISSIONER PHILLIPS, SECONDED BY COMMISSIONER FELLER, AND UNANIMOUSLY CARRIED ON A POLLED VOTE, THE CRESCENT CITY HARBOR DISTRICT BOARD OF COMMISSIONERS APPROVED AND ADOPTED THE CONSENT AGENDA CONSISTING OF ITEMS 1. A-B, AS PRESENTED.

2. Discussion and consideration of A RESOLUTION OF THE CRESCENT CITY HARBOR COMMISSION DECLARING AN EMERGENCY UNDER PUBLIC CONTRACT CODE SECTION 1102 AND AUTHORIZING NEGOTIATION OF A CONTRACT TO ADDRESS ELECTRICAL ISSUES IN THE INNER BOAT BASIN OF THE HARBOR. Take action as necessary and appropriate.

Mr. Helms commented the vessels have been giving out an electrical charge and is a physical hazard to people on the Harbor. Commissioner Feller asked what generated this problem.

ON A MOTION BY COMMISSIONER FELLER, SECONDED BY COMMISSIONER RAMSEY, AND UNANIMOUSLY CARRIED ON A POLLED VOTE, THE CRESCENT CITY HARBOR DISTRICT BOARD OF COMMISSIONERS APPROVED AND ADOPTED THE RESOLUTION OF THE CRESCENT CITY HARBOR COMMISSION DECLARING AN EMERGENCY UNDER PUBLIC CONTRACT CODE SECTION 1102 AND AUTHORIZING

NEGOTIATION OF A CONTRACT TO ADDRESS ELECTRICAL ISSUES IN THE INNER BOAT BASIN OF THE HARBOR.

3. Discussion and consideration of cancelling the prior lease with North Coast Ocean Sports which has been superseded by a new lease with North Coast Ocean Sports & Grill. Take action as necessary and appropriate

Mr. Helms commented the board approved the lease on September 1, 2015. President White asked what are one-business services vs. the other. Mr. Helms commented North Coast Ocean Sports was going to rent bikes and paddle boards, but now North Coast Ocean Sports & Grill will be running a restraunt as well as renting bikes and paddle boards. President White asked if this included a mobile building. Mr. Helms commented that it did.

ON A MOTION BY COMMISSIONER RAMSEY, SECONDED BY COMMISSIONER BAILEY, AND UNANIMOUSLY CARRIED ON A POLLED VOTE, THE CRESCENT CITY HARBOR DISTRICT BOARD OF COMMISSIONERS APPROVED AND ADOPTED THE CANCELATION OF THE PRIOR LEASE WITH NORTH COAST OCEAN SPORTS WHICH HAS BEEN SUPERSEDED BY A NEW LEASE WITH NORTH COAST SPORTS & GRILL.

4. Discussion and consideration of the amended Fee Schedule that received prior consent from the Board of Harbor Commissioners. The Fee Schedule has been posted for the required 30-Day Public Notice period and is ready for Board of Harbor Commissioners consideration and action. Take action as necessary and appropriate

Discussion was held in regards to the amended fee schedule. President White recused himself. Commissioner Feller took over. Richard Haggle commercial fisherman commented there was discussion in regards to a fee for storing crab pots. Commissioner Bailey commented that there is no fee for gearing up and gearing down periods. Mr. Haggle asked what does that mean. Commissioner Bailey commented when you drop off and pick up a month after your season begins or ends. Commissioner Ramsey commented it is in regards to crab pots being stored after and before the gearing up and gearing down crab season. Commissioner Feller commented the goal was to take care of a nuisance problem after crab season.

ON A MOTION BY COMMISSIONER BAILEY, SECONDED BY COMMISSIONER RAMSEY, AND UNANIMOUSLY CARRIED ON A POLLED VOTE, WITH PRESIDENT WHITE RECUSED, THE CRESCENT CITY HARBOR DISTRICT BOARD OF COMMISSIONERS APPROVED AND ADOPTED THE AMENDED FEE SCHEDULE THAT RECEIVED PRIOR CONSENT FROM THE BOARD OF HARBOR COMMISSIONERS.

Commissioner Phillips asked where are we going to specify what the gearing up and gearing down periods are. Mr. Helms commented that would vary to the season. Commissioner Phillips asked if this is part of the ordinance. Mr. Helms commented that it is.

5. Discussion and consideration of the offer from the National Oceanic and Atmospheric Administration (NOAA) to place their tsunami boat on loan to the Crescent City Harbor District for public display. Take action as necessary and appropriate

Discussion was held in regards to the National Oceanic and Atmospheric Administration (NOAA) to place their tsunami boat on loan to Crescent City Harbor District for public display. President White returned and finished the rest of the meeting. Commissioner Ramsey commented there is someone from the public who would like to be apart of that project. Commissioner Ramsey noted he would like to put up a projector that displays different pictures. Commissioner Phillips asked where would the boat be placed. Mr. Helms commented over by the old fish station. Commissioner Bailey asked if the boat would fit there. Mr. Helms commented that the boat would. President White asked if the boat would be permanent or just temporary. Mr. Helms commented it is in comparison to the loan of the whale to the marine mammal center.

ON A MOTION BY COMMISSIONER BAILEY, SECONDED BY COMMISSIONER RAMSEY, WITH COMMISSIONER RAMSEY ABSTAINED AND UNANIMOUSLY CARRIED ON A POLLED VOTE, THE CRESCENT CITY HARBOR DISTRICT BOARD OF COMMISSIONERS APPROVED AND ADOPTED THE NATION OCEANIC AND ATMOSPHERIC ADMINISTRATION (NOAA) TO PLACE THEIR TSUNAMI BOAT ON LOAN TO THE CRESCENT CITY HARBOR DISTRICT FOR PUBLIC DISPLAY.

Commissioner Phillips asked if the boat would be enclosed or open to the public. Mr. Helms commented it would be open to the public. Commissioner Phillips asked how would the Harbor know if the boat would be safe from vandalism or

damage. Mr. Helms commented there isn't a lot on the boat for people to damage. Commissioner Feller asked in regards to the release of liability from NOAA.
