- A. Distribute the booklet "Preparing and Protecting California Elected Official's Guide to Emergencies in California" from the California Governor's Office of Emergency Services. Review and discuss booklet content.

- **C. Review Properties for sale adjoining the Harbor District.** Review possible advantages and/or disadvantages about acquiring properties adjoining the Harbor District.
  - 1) 000 Anchor Way, 5.06 undeveloped acres immediately south of Anchor Way, US Hwy 101 South frontage, \$300,000;
  - 2) 150 Starfish Way, Harbor View Grotto Facility, \$850,000;
  - 3) 450 US Hwy 101 South, undeveloped 2,867 sq. ft. lot property, bordered on north by Travelodge and backs to Purple Cat, \$47,000.
- **D.** Discuss and approve writing a letter to the Pacific Fishery Management Council supporting an expeditious study of Open Access concerning all the species of Rockfish. The council is considering performing a study for hook and line fishing for fishers targeting groundfish without limited entry permits and fishers who participate in non-groundfish fisheries that incidentally catch groundfish. The support letter would urge the Council to perform the Open Access study.
- E. 2020 Board of Directors' Officers Elections. Nominate candidates and conduct election for Board President and Board Secretary for 2020 Calendar Year.
