- A. Approval of Resolution 2020 003 Ordering an Election, Requesting County elections to Conduct the Election, and Requesting Consolidation of the Election. Review and approve.
- B. Discuss and approve continuing or revising concessions to tenants in light of the COVID-19 Coronavirus Pandemic restrictions. At the 5 May Harbor Commission meeting, the Board of Harbor Commissioners approved a three month lease payment forgiveness action which ends on 30 June, 2020, for the District's three foodservice tenants and the forgiveness of the minimum monthly lease payment from Englund Marine. Discuss and approve continuing or revising the terms of lease payment concessions to Harbor District tenants.
- C. Report from Mike Baker, Harbor District Facility Manager, on responses he has received from local propane dealers concerning his inquiry about the feasibility of the Harbor District RV Parks having the ability to exchange propane tanks for tenants and guests. Discuss Mr. Baker's presentation, compare offers from propane dealers, and decide, based on the proposals, if the Harbor District should offer the service and with which vendor it should enter into a service agreement.

Review and approve the purchase of the two lots for the offered price of \$25,000 and direct Harbor Master to complete all associated paperwork to affect the transfer of ownership from the seller to the Crescent City Harbor District.
